The above-referenced property has been identified as having significant damage from Hurricane Michael, and needs repair. At our last inspection on November 17, 2021, this property was determined to be in violation of Bay County Code Section 17-2 in the form of an unfit/unsafe structure, debris and overgrowth. The following actions must be taken to correct the above stated violations:

- Unsafe conditions must be corrected. A detailed action plan and scope of work from a licensed structural engineer will be required before building permits may be obtained and work can begin. If the structure is located in a flood zone, a Substantial Damage determination from the Bay County Certified Floodplain Manager may be required. Contact Planning & Zoning at 850-248-8250 for more information.
Alternatively, the structure may be demolished, and all debris removed from the property. A demolition permit must be obtained from Bay County Builders Services prior to beginning work.
Derelict vehicles must be stored in an enclosed structure, made operable with current registration, or removed from the property.
A safety barrier must exist around the swimming pool. The broken fence must be replaced or repaired to prevent access.
All trash and debris must be removed from the property and disposed of lawfully.
All overgrown grass or weeds must be cut or mowed.

This correspondence will serve as official notification that the above stated violations must be corrected before January 17, 2022.

This case is scheduled to be presented to the Special Magistrate for Bay County at the hearing on January 20, 2022, at 9:00am CST at the Bay County Government Center located at 840 W. 11th St., Panama City, Florida. If found in violation, the Magistrate may order the violations be corrected. Fines, liens or special assessments may be placed on the property for noncompliance and/or the costs of abatement, repair or demolition by the County.
