RE: Addendum #2 22-30 9th Street Fuel Island Generator

Please accept this as Addendum No. 2 for the above referenced solicitation.

The following question has been received. The County's answer follows in **bold**.

1. At generator startup is load bank testing required? **Yes.**
2. If yes how long a test is required (2 hour, 4 hour)? **2 Hours.**
3. Please confirm that the intent is to back up the entire service, both panels. **No, just the distribution panel serving fuel island.**
4. What is the County's plan for the power outage. This outage could exceed a single day. Can it be done during normal working hours? Will it have to be done off hours? Please advise. **The County will provide backup generator equipment to service fuel island while it is down, the contractor will be required to make the connection from the supplied portable generator to Fuel Island Service panels.**
5. Is the County paying for any/all FPL charges? **The County will be responsible for any charges/fees required by Florida Power and Light associated with this project.**
6. Are bollards required around the generator? **No, if bollards are deemed necessary, County staff will install them.**
7. Please confirm fuel tank size in terms of running hours at full load and who is to supply the fuel. **The tank size will need to accommodate enough fuel for a 48 hour generator run time. The County will supply the fuel.**
8. Is there a fuel tank run time requirement for this project and will Bay County be providing the initial fill-up? **Run Time- 48 Hours, Bay County will provide initial fill up.**

9. Is there a requirement for generator to be located outside or elevated above the 500 year flood plain? **Generator will be elevated above 500 year flood plain.**

10. Is there a minimum require wind rating for the enclosure? **150 mph.**

11. Please verify warranty terms. **Standard one year contractor's workmanship and materials warranty. Standard equipment manufacturer's warranty.**

12. Estimated budget? **\$160,263.00**

All respondents shall acknowledge receipt of this addendum by signing and submitting, with their bid, the addendum acknowledgement form included in the Bid package.
